Group that exposed genocide in Canada to begin direct actions on February 9 - Protests and occupations will target *"ongoing crimes against humanity"* by China, churches, corporations

Vancouver:

The citizens movement that revealed and prosecuted Indian residential school crimes in Canada is launching a new direct-action campaign on February 9, the 25th anniversary of the movement's birth.

Between 1998 and 2015, the Friends and Relatives of the Disappeared (FRD) held high-profile protests, Tribunals, and church occupations that eventually forced Canada and its churches to admit to genocide. Now a revived FRD has launched a new coalition to confront and halt ongoing crimes against humanity, especially on Canada's west coast.

The Coalition includes the FRD and the traditional Chilcotin, Squamish, and Anishinaabe nations, human rights groups, the sovereign Republic of Kanata, and the International Tribunal of Crimes of Church and State, which helped force Pope Benedict out of office in February 2013.

"Once again, we are saying no to the institutionalized slaughter of the innocent," said Kevin Annett, one of the original founders of the FRD and a spokesman for the new Coalition. "We are taking the fight to the criminals by aiming at the modern perpetrators of genocide and child killing in Canada: China, its puppet government in Ottawa, Big Pharma, and their partners in crime, the Catholic, Anglican, and United churches, that have all been legally evicted from Vancouver." Under a Supreme Court of British Columbia Notice dated March 4, 2008, Kevin Annett is legally empowered to enter these churches and enforce Squamish hereditary chief Kiapilano's Eviction Order that banned them from his territories, encompassing Vancouver. *(See Attachment #1)*

The upcoming campaign will include public teach-ins and training workshops between February 9 and 12, followed by direct actions at churches and other locations on selected dates. An International Day of Action will occur on Sunday, February 26, the 12th anniversary of the medical murder of eyewitness William Combes at St. Paul's Hospital in Vancouver. *(See Attachments #2-7)*

Suzanne Holland, Ambassador of the traditional Chilcotin indigenous nation, endorses the new coalition and is organizing its actions in the Chilcotin territory of central British Columbia.

"We have expelled the genocidal churches from our land and reclaimed their properties as reparations for their crimes against our people. We ask all indigenous nations to do the same as part of our new coalition."

1.0 <u>TEMPORARY FIDUCIARY POWER OF ATTORNEY</u>: <u>This Notice of Appointment is issued to</u> Kevin Annett aka Eagle Strong Voice to be the Named temporary fiduciary Power of Attorney over the attached Eviction Notice to the Named churches;

4.0 <u>UNCONDITIONAL NOTICE OF EVICTION</u>: The Anglican, Catholic and United Churches were given a time limitation to respond to the registered Notice issued to the UN and named individuals who were served personally by Kevin Annett Eagle Strong Voice. To this day, I have received nothing from these representatives of these said churches or government officials. Representatives of these churches therefore are given 3 days in which to remove all their personal assets before Kevin Annett and his assistants enforce this Notice of Eviction to take over all the Named churches and buildings located on my Squamish[™] Nation lands and open the doors to the poor, hungry and homeless people on Squamish[™] Nation lands regardless of race, creed or color;

5.0 <u>RIGHT OF ENTRY</u>: As the Landlord to the Squamish[™] Nation lands and natural resources, I appoint Kevin Annett Eagle Strong Voice to act with a Right of Entry to claim the said buildings of all the Anglican, Catholic and United churches located on Squamish[™] Nation Territory. Kevin's position as the temporary fiduciary Power of Attorney is to assert this undertaking of a Right of Entry as an equitable remedy to the silence of the Named representatives of these churches. I concur with an Admiralty/Maritime jurisdiction legal ease claim that their silence is a tacit consent to all the terms and conditions contained herein. Kevin is given full authority to access the burial sites for excavation, conduct of forensic research as to the cause of death, provide a proper traditional burial pursuant to Squamish[™] nation ancient ways and surrender those who are responsible for this genocide to my people to an on camera Examination for Discovery or pubic international inquiry conducted by hereditary/traditional Chiefs of Turtle Island. 6.0 <u>GOOD FAITH</u>: Whereas Kevin Annett Eagle Strong Voice will exercise scrupulous good faith and candor towards, and for the benefit and on behalf of Royal Hereditary Chief: Kiapilano[™], Creditor, Secure Party, Author of Trademark to the Copyright Name autograph for the BUSINESS CORPORATE NAME ©CHIEF CAPILANO in any style of cause, the exclusive and limited purpose of accepting and receiving all service of process to this Eviction Notice of the Named Churches. Kevin Annett Eagle Strong Voice may at any time relinquish his temporary fiduciary appointed position as a Power of Attorney for this task of claiming a Right of Entry to the Anglican, Catholic and United Churches on Squamish[™] Nation territory;

7.0 <u>ARREST WITHOUT WARRANT</u>: Kevin Annett Eagle Strong Voice may appoint Peace Officers of the RCMP, CBP and local community police detachment officers and constables to assist him pursuant to the Supreme Court Rules to act in my best interest to protect himself, his assistants, me, my family, my property and assets and Named Creditors pursuant to Notice of Arrest without warrant by any person pursuant to Section 494.(1). Pursuant to Arrest by owner of property S. 494.(2), Kevin Annett Eagle Strong Voice has my written authority to contact the provincial and federal RCMP and Police detachments for assistance with this Notice as a separate Notice of Appointment was issued to the RCMP under a registered Constructive Notice to the said security forces in December 2007. Dick Bent, Superintendent of the RCMP may be contacted at 604-264-2223 as he confirmed receipt of this Notice on January 3, 2008 and my Power of Attorney Claim to the lands and premises described to the BC Land Title and Survey, INAC and Squamish[™] Band Council office. The difference with this appointment is that Named churches are an addition to the Power of Attorney claims on Squamish[™] Nation territory;

<u>Note</u>: Kevin is also legally empowered by this Legal Notice to make citizen's arrests and deputize police to assist him in seizing the properties of these churches, which are illegal squatters and are trespassing on Squamish land.

4. Excerpts from Chloe Kirker's affidavit of October 14, 2017, describing evidence of arsenic poisoning of William Combes prior to his death.

The fingernail bed lines I observed and his lethargy, overall weakness, soreness and dizzy spells upon standing which i charted did indicate a condition that was not TB. I never got any answer other than malnutrition for these symptoms. <u>The fingernail lines are called Mee's lines, and they appear in a person who has been poisoned with arsenic.</u>

The occasional vomiting I observed in William, his lack of appetite, dark strong smelling urine and loose bowel movement and overall soreness, 'room spinning' he reported which is a sign of vertigo combined with the presence of the Mee's lines, in hindsight really point to him as having been exposed to arsenic over a period of time.

It is a difficult realization to behold, but obvious now that the way William was killed was by arsenic blood poisoning, not 'undiagnosed blood borne infection' as stated to me on several occasions, was necessitated by Williams public role in disclosing the atrocities done at the Kamloops res. school. They simply could not beat him to death as they had the others, they had to do it as if it had happened of 'natural causes'

The only medication he was on, lasix/furosemide is a diuretic, it would have sped up all fluids in his body to leave his systems, i.e.: evidence of the arsenic to leave his system. By William not having an LV. meant that any damage the arsenic was doing to his organs, tissues would be concentrated in his body.

5. Report of British Columbia Chief Coroner Claire Thompson claiming that William Combes died of "*disseminated tuberculosis*", despite his absence of TB symptoms. Note that Thompson declares his death as "natural", that toxicological testing is "not necessary", and that her report is dated June 13, 2011, four months after William's death.

6. News report of William's death and an excerpt from his account of the abduction and disappearance of ten Kamloops residential school children by Queen Elizabeth on October 10, 1964.



In October, 1964 when I was 12 years old, I was an inmate at the Kamloops school and we were visited by the Queen of England and Prince Phillip. I remember it was strange because they came by themselves, no big fanfare or nothing. But I recognized them and the school principal told us it was the Queen and we all got given new clothes and good food for the first time in months the day before she arrived.

The day the Queen got to the school, I was part of a group of kids that went on a picnic with her and her husband and some of the priests, down to a meadow near Dead Man's Creek. I remember it was weird because we all had to bend down and kiss her foot, a white laced boot.

After awhile, I saw the Queen leave the picnic with ten children from the school, and those kids never returned. We never heard anything more about them and never met them again even when we were older. They were all from around there but they all vanished.

The group that disappeared was seven boys and three girls, in age from six to fourteen years old. They were all from the smart group in class. Two of the boys were brothers and they were Metis from Quesnel. Their last name was Arnuse or Arnold. I don't remember the others, just an occasional first name like Cecilia and there was an Edward.

What happened was also witnessed by my friend George Adolph, who was 11 years old at the time and a student there too. But he's dead now.
